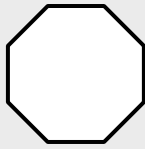
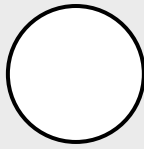

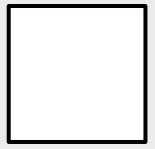

## Informed Consent and Screener for COVID-19 Immunization

I also release **Urgent Care Now** and affiliates, employees, and volunteers from all liability, including acts of omission or commission, resulting, or arising from my receipt of this vaccination. I understand that: 1) I have voluntarily chosen to receive the vaccination. 2) I am of legal age and authorized to execute this consent form. 3) I will immediately alert the vaccine administrator of any medical conditions which may adversely affect my personal health or effectiveness of the vaccine. 4) I have been counseled about potential side effects after vaccination, when they may occur, and when and where I should seek treatment. I am responsible for following up with my physician at my expense if I experience any side effects. 5) I should remain in the area for 15 minutes after the vaccination for observation or 30 mins if I have reported severe allergies or reactions to medications, food vaccines or latex. 6) I have read, or have had read to me, the fact sheet provided for the vaccine(s) to be administered. I have had the opportunity to ask questions, and all my questions have been answered to my satisfaction. I understand the benefits and risks of the vaccine(s). 7) This vaccination, including any vaccination granted additional privacy protections under state or federal law, is subject to reporting to an immunization registry, which may share my immunization data with others or the local Department of Health, if applicable, and I authorize these disclosures.
